RESPONSIBILITY: The Daffodil Arabian Horse Association of Washington, Inc., (DAHA) will not be held responsible for any loss, damage or injury to horses exhibited or for any article of any kind or nature that may be lost or destroyed, or to any person, whom may be injured by any horse exhibited at its horse shows. The owner of any horse, who is held to be responsible for any injuries, shall indemnify DAHA against all claims and demands of any kind or nature that may grow from negligence of the person in charge of any such horse. All horses exhibited in the shows will be entirely at the owner's sole risk.

US EQUESTRIAN FEDERATION MEMBERSHIP REQUIREMENTS

Life, senior active and junior active members shall be eligible to participate in all classes at Regular Competitions, Eventing Competitions at the Preliminary Level or above and Combined Driving Competitions at the advanced level, Dressage, Reining and Vaulting Competitions and Endurance Rides provided the respective breed/discipline dues or breed/discipline category fee has been paid. A non-member may participate as a handler, rider, driver, owner, lessee, agent, coach or trainer at Regular Competitions, Eventing Competitions, Dressage Competitions, Reining Competitions and Combined Driving Competitions upon payment of a \$30.00 non-member registration fee. Participants in the following classes are exempted from the requirements of this rule: 1) leadline; 2) exhibitions; 3) games and races; 4) classes for 4-H members; 5) walk/trot and academy classes (academy classes are classes limited to horses used regularly in a lesson program); 6) USDF introductory level tests, pas de deux and quadrille classes; 7) NRHA endorsed Reining Competitions; 8) Opportunity classes; 9) citizens of other nations who have proof, in English, of current membership in good standing of their own National Federation; 10) USEA beginner novice division; and 11) assistant handlers in Dressage Sport Horse Breeding classes. (See GR807.4 of the Federation rules.)

US EQUESTRIAN FEDERATION ENTRY AGREEMENT

By entering a US Equestrian Federation licensed Competition and signing this entry blank as the Owner, Lessee, Trainer, Manager, Agent, Coach, Driver, Rider or Handler and on behalf of myself and my principals, representatives, employees and agents. I agree that I am subject to the Constitution and Rules of US Equestrian Federation and the local rules of the competition. I will accept as final the decision of the Hearing Committee on any question arising under the Rules and agree to release and hold harmless the competition, the Federation, their officials, and employees for any action taken under the Rules.

I represent that I am eligible to enter and/or participate under the rules, and every horse I am entering is eligible as entered.

I also agree that as a condition of and in consideration of acceptance of entry, the Federation and/or the competition may use or assign photographs, videos, audios, cablecasts, or other likenesses of me and my horse taken during the course of the competition for the promotion, coverage or benefit of the competition, sport, or the Federation. Those likenesses shall not be used to advertise a product and they may not be used in such a way as to jeopardize amateur status. I hereby expressly and irrevocably waive and release any rights in connection with such use, including any claim to compensation, invasion of privacy, right of publicity, or to misappropriation.

The construction and application of Federation rules are governed by the laws of the State of New York, and any action instituted against the Federation must be filed in New York State. See GR 908.4.

MEMBERSHIP AFFIDAVIT FEE: Affidavits are no longer accepted IF A PERSON IS A NON-MEMBER, THEY MUST PAY THE NON-MEMBER FEE. IF AN INDIVIDUAL WHO IS NOT A MEMBER FILLS OUT AN AFFIDAVIT A FINE OF \$200.00 WILL BE ASSESSED BY US EQUESTRIAN FEDERATION.

US EQUESTRIAN FEDERATION NON-MEMBER/AMATEUR CERTIFICATION: Any exhibitor who wishes to compete at these competitions must be a member of US Equestrian Federation or pay a non-member fee. All persons entering classes restricted to amateurs (adults 18 and over) must present proof of amateur certification issued by the US Equestrian Federation; non-members who require amateur certification must file a non-member amateur application and pay a \$30.00 fee and the \$30.00 non-member fee

DAHA SHOWS RULES AND REGULATIONS

USEF/AHA RULES: Every class offered herein which is covered by the rules and specifications of the current USEF Rule Book and AHA Handbook will be conducted and judged in accordance therewith. Exhibitors are urged to join USEF and AHA to familiarize themselves with the rules.

ADMISSION TO ARENA: No person may enter the space set aside for the judging or hold any communication with the judge or examining veterinarian without permission of the show committee or steward, who will arrange an appointment with the judge at a proper time and place. Failure to comply with this request could result in disqualification from subsequent classes and forfeiture of all entries, prize money, awards and ribbons.

AGE OF HORSE AND RIDER: For horse show purposes any horse shall be considered to be 1 year old on the first day of January following the actual date of foaling. Junior exhibitors are those who have not reached their 18th birthday by December 1, 2008. Junior exhibitors are considered amateurs and do not need amateur certification.

AHA MEMBERSHIP REQUIREMENTS: A current AHA Competition Level Membership is required for all owners, trainers, riders, drivers & handlers OR a Single Event Membership must be purchased for \$30 per person.

AHA YOUTH ACHIEVEMENT AWARDS PROGRAM: An official point sheet will be maintained by the contestant and must be signed by each Show Secretary and submitted to AHA by the rider at the end of each calendar year to qualify for the Youth Achievement Awards.

AMATEUR OWNER AND JUNIOR OWNER: Horses entered in amateur owner and junior owner classes must be registered in the name of the competitor or a member of the competitor's family. (Horses registered in a farm/ranch/syndicate/ partnership/corporation name may be shown in Amateur Owner classes provided the family is the sole owner of the farm or entity as defined by USEF. The sale of a horse does not eliminate this registration requirement. (Contracts of Sale or Bills of Sale will not be accepted in Amateur and Junior Owner Classes.)

ARENA LOCATIONS: The main arena is located in the Paulhamus Arena. The arena is 100 x 200 and has sandy loam/topsoil footing. Covered warm-up arena is the Contest arena. The Contest arena is 60x180 and has sandy loam/topsoil footing over concrete. There is an uncovered lunging area between the Draft Horse barn and Paulhamus Arena which has topsoil/sand footing.

ATTENDANTS: All attendants must be neatly and properly dressed. A white smock is usual. Special attention should be given to dress and demeanor on entering the show ring. Stripping of horses is optional at judge's discretion.

BEDDING AND FEED: The first bedding is supplied. **Additional bedding will be available FOR PURCHASE on the grounds.** Feed is available in the local vicinity.

CANCELLATION OF CLASSES: The Show Committee reserves the right to cancel classes with fewer than 3 entries.

CAMPER FEES: Camper fee is \$20.00 per day and will be collected. Power and water are available on a first-come, first-served basis in the RV lot across 5th Street. To the rear are full hookups, which include septic.

CONDUCT: Excessive use of a whip on any horse in a stall, runway, schooling area, show ring or elsewhere on the show grounds, before or during a show, constitutes a violation and renders the offender subject to penalty. Except in the harness classes, no whip over six feet long, including snapper, may be used when showing a horse.

DISCIPLINE: Exhibitors are warned that any act of discourtesy or disobedience to the officials on the part of the owner, trainer or rider will disqualify the horse from adjudication. The show committee reserves the right to remove a horse, owner, rider or groom from the show without being liable for compensation or damages. It is a violation of USEF rules to commit any act or make remarks during the show considered offensive or made with intent to influence or cast aspersions on the judging, and any exhibitor may be barred from the show for this offense.

DISPOSAL OF NEEDLES: "Sharps" is the title given to hypodermic needles and syringes. Even in the equestrian environment, used Sharps are contaminated by contact with equine body fluids. Awareness of handling and proper disposal of Sharps contributes to the well being and safety of humans and animals. Any owner, trainer, exhibitor or their agents, who improperly disposes of needles or other sharp disposable instruments may be fined \$100 by competition management pursuant to USEF rules. Competition management will place Sharps disposal containers in the barn areas.

DISPUTE NOT COVERED BY RULES: Should any question arise not provided for in the governing rules, the same shall be referred to the show committee whose decision will be final.

DOGS: **The Western Washington Fair Management does not allow dogs on the grounds during events. They have been bending this rule for horse shows and will continue to do so with the following understanding: dogs must be on a leash at all times and cannot be a safety or noise problem. Owners must clean up after their dogs and are financially liable for any dog-related incidents, including damage.**

DRUGS AND MEDICATIONS: Refer to USEF Rules.

FIRE MARSHAL RULES: By order of the Fire Marshal, all aisles between stalls must remain open. **All materials used for decorative purposes must be treated with flame retardant; this includes stall drapes, even those made of Cordura.** Please be prepared to present evidence to the Puyallup Fire Department. The Fire Marshall will be inspecting the grounds. Authorized electrical appliances for grooming purposes may be used. The electrical system may not be altered or tampered with under any circumstances. If electrical extension cords are used, they must be of the heavy-duty, outdoor, type (orange in color). **NO SMOKING IS ALLOWED IN THE ARENAS OR BARN AREAS ON THE FAIRGROUNDS.**

FOOD ON GROUNDS: Food will be available from concessions on the show grounds during the hours of each class session.

HORSES ON GROUNDS: Due to limited permanent stabling, only horses entered in the show will be assigned stalls. All horses on the grounds **MUST** be entered and stabled on the show grounds. ***THIS RULE WILL BE STRICTLY ENFORCED. All horses on the grounds will be restricted to horse designated areas.***

HORSE SHOW OFFICE: Located on the SW corner of the Paulhamus Arena, the show office will open at 2:00 p.m. on August 7, 2009 and remain open until 8:00 p.m. Thereafter, hours are 30 minutes prior to the beginning of each class session and the end of each class session.

IDENTIFICATION NUMBERS: Every horse entered in the Show will be assigned a number. It is important, for the proper handling of the Show, that riders, handlers, or drivers in all classes wear the correct number. Number to be worn on exhibitor's back clearly visible to the Judge at all times when in competition, except for reining and trail classes when number may be placed on saddle pad.

LOCATION OF CLASSES: The Show reserves the right to change the arena location of classes with notification to exhibitors.

OPERATION OF MOTORIZED VEHICLES: USEF GR 1301.7: Minors who do not have a valid driver's license which allows them to operate a motorized vehicle in the state in which they reside will not be permitted to operate a motorized vehicle of any kind including, but not limited to, golf carts, motorcycles, scooters, or farm utility vehicles on the competition grounds of recognized competitions. Minors who have a valid temporary license may operate the above-described motorized vehicles as long as they are accompanied by an adult with a valid driver's license. Violations of this rule will be cause for sanctions against the parent(s), guardian(s) and/or trainer(s) who are responsible for the child committing the offense. Penalties may include exclusion of the child, parent(s), guardian(s), and/or trainer(s) from the competition grounds for the remainder of the competition and charges being filed against any of the above individuals in accordance with Rule 6. Wheelchairs and other mobility assistance devices for individuals with disabilities are exempt from this rule. Proof of insurance must be available for golf carts, scooters and motorcycles.

PARKING: Exhibitor parking for automobiles, trucks and trailers will be available on the lot located across 5th Street (opposite the green gate). Spectator parking is available in the lot opposite the Blue entrance gate.

PARKING ON GROUNDS: No parking is allowed on the show grounds. Temporary permits for loading/unloading, only, will be available. **Horse trailers will be allowed on the grounds to load and unload only.**

PROTECTIVE HEADGEAR: USEF GR801.4.

PROTEST: A protest must be writing and addressed to the secretary of the show and accompanied by a deposit of \$200.00 for members and \$300.00 for non-members. The secretary, show manager or show committee must receive it within 48 hours of the alleged violation. All protests will be handled according to USEF rules.

REGISTRATION: In classes for Arabians, horses must be registered with the Arabian Horse Association (or in the case of a foreign entry, which has not been issued said certificate of registration, have been issued a Competition Visa by the Arabian Horse Association), and/or the Canadian Arabian Horse Registry, or, if under 1 year of age, be eligible for registration and registration applied for. Entry must be made under the full registered name. (Only weanlings that have had registration applied for may show without registration papers). Half-Arabians/Anglo-Arabians must be registered with the Arabian Horse Association in the Half-Arabian and/or Anglo-Arabian Registry, or have been issued an Arabian Horse Association (Canadian Partbred Arabian Register) CPAR PERMIT or, if under 1 year of age, be eligible for registry and registration applied for and must be entered under their full registered name.

SHOEING REGULATIONS: Refer to USEF Rules.

STALLIONS: Stallions may be shown in junior exhibitor/ladies classes.

STALL SET-UP FOR BARN FRONTS: For the safety of show spectators, exhibitors assigned stabling in the front of barns A – D will not be allowed vehicle access to the front barn area. Loading can occur via the back of the barns. Your cooperation is appreciated.

STALL AND BARN DAMAGE: Stalls may not be structurally altered in any way. Stalls must be vacated in their original condition. Do not put nails, screws or other type of hole producing devices into the stall walls. Hooves are not to be painted on unprotected barn floors and aisles. Exhibitors are responsible for any damage to stalls or barn and will be charged accordingly. The Fairgrounds will be inspecting stalls and barns for damage/alterations. The use of staples, tacks, or tape to attach decorations to walls, buildings, stalls, etc., is prohibited. Decorations must be removed by the exhibitor.

STALL AREA CLEANUP: Exhibitors are responsible for cleanup and disposal of materials other than shavings used in stalls. This includes any materials placed in aisles, outside barns or materials used for decorative purposes. The cost of cleanup will be \$35/hour and \$10 per yard dumping fee for cleanup and disposal of materials other than actual stall bedding.

STORM SEWERS: Storm sewers are the drains located in various areas on the fairgrounds which discharge directly into Meeker/Clarks Creek and into the Puyallup River. The water entering the storm sewers is not treated to remove contaminates. Not only are the pollutants hazardous to water life, it contributes to overgrowth in the creek causing water to back up and flood. Nothing is to be poured into the sewers. Anyplace where there is asphalt on the grounds, there are storm sewers for run-off. For that reason it is imperative that nothing be dumped or poured onto asphalt or concrete on the fairgrounds. All shavings and manure dumped onto asphalt or concrete must be immediately disposed of in the designated dumpsite. This includes manure from trailers.

TIME SCHEDULE: Entries in all events must be ready and report to the paddock steward promptly. Exhibitors are reminded that although every reasonable effort will be made to maintain a functional announcement system and make adequate class calls, this service is a courtesy. It is the exhibitor's responsibility to have his or her horse at the in-gate on time.

UNSUPERVISED CHILDREN: Children are not allowed to ride bicycles or roller blade on the fairgrounds. In the past there have been many incidents of vandalism, which appears to be related to unsupervised children.

VETERINARIAN: USEF GR1211.4: The show veterinarian will be on-call.

POST ENTRIES: Early entry is advised, as stabling may not be available for late post entries. Post entries will be taken daily, during office hours. **(CLASSES MUST BE ENTERED AT LEAST ONE SESSION IN ADVANCE–NO EXCEPTIONS.)** Show management reserves the right to accept post entries at regular fees for unfilled classes. All post entries will be assessed a post entry fee in addition to the normal entry fee as noted above.

ENTRIES CLOSE JULY 15, 2009. Entries must be postmarked no later than July 15, 2009. If postal meters are used to stamp entry envelopes, these entries must arrive by closing date or **POST ENTRY** will be charged.

AMATEUR OWNER AND JUNIOR OWNER: Horses entered in amateur owner and junior owner classes **must** be registered in the name of the competitor or a member of the competitor’s family, as defined by USEF rules. (Horses registered in a farm/ranch/syndicate/partnership/corporation name may be shown in Amateur Owner classes provided the family is the sole owner of the farm or entity as defined by USEF rules. The sale of a horse does not eliminate this registration requirement. **(Contracts of Sale or Bills of Sale will not be accepted in amateur and junior owner classes.)**)

YOUR ENTRY MUST INCLUDE:

1. Completed entry form with signatures of owner, trainer and all handlers, riders or drivers. Only one owner can appear on each entry. Both Owner and Trainer must sign the entry form in the spaces provided. If Owner and Trainer are the same, Owner must sign as both

Owner and Trainer. Parent/guardian signature is required for all Junior Exhibitors. If owner is a youth without a trainer, the parent may sign as trainer and does not have to pay the USEF Non-Member or AHA Single-Event fees.

2. Photocopy of **horse's registration papers** - both sides please. **Horses one year of age and over must be registered in order to compete.**

3. Photocopy of 2009 **USEF membership** (with **amateur certification** if competing in adult amateur classes) and **AHA membership cards** for owner, rider, driver, handler, trainer, agent.

4. Photocopy of **lease agreement**, if horse is being leased. Leased horses are not eligible to show with lessee in owner classes unless the lessee and leasor are members of the same family.

5. Photocopy of **sales contract** or **bill of sale** if horse is not registered in name of person showing. If the horse is being purchased on contract, it should be entered in the name of the person who is purchasing the horse.

6. Entries will not be accepted by telephone, fax or e-mail. No post-dated checks will be processed. Every entry must be accompanied by a check or money order for the full amount of entry fees payable in U.S. dollars. There will be a **\$40.00** fee for checks dishonored for any reason. Payment of entries, which are non-collectable, will be reported to USEF & AHA. **NO ENTRIES WILL BE ACCEPTED OR PROCESSED UNTIL ALL ENTRY COSTS AND FEES ARE PAID. PURSUANT TO USEF RULES, THIS COMPETITION DOES NOT ACCEPT UNPAID ENTRIES.**

WITHDRAWAL OF ENTRIES: The Show Committee agrees to refund entry and stabling fees on any horse not fit to show, provided written notice is given on or before closing date of July 15, 2009. After closing date, withdrawal must be accompanied by an official veterinarian's certificate. In such cases, refund of entry fees will be given less a \$15.00 office charge per horse and the AHA 9-90 fee. **Stall and tack/ready room fees will not be refunded for any reason or event after July 15, 2009. After 5:00 p.m. on August 7, 2009 there will be no refunds of any fees.**

REFUND OF ENTRIES: Entry fees will not be refunded in the event of cancellation of classes due to severe weather or other emergency beyond the control of show management and the show committee. In the event the show is cancelled for any other reason, show entry fees, less the office fee and mandatory fees, will be refunded within 30 days.

AWARDS: 1st Place Trophy and ribbons to 5 places except as follows:

CHAMPIONSHIPS: 1st Place Trophy and ribbons to 6 places

HALTER CHAMPIONSHIPS: Trophy, Champion and Reserve Ribbons

MEDAL EQUITATION: Silver medal and ribbons to 8 places

EQUITATION: Trophy and ribbons to 6 places

CLASSIC HEAD: Trophy and ribbon to 1st place only

LEADLINE: All exhibitors will receive first place awards and ribbons

PRIZE MONEY will be paid (by check) at the show from the Show office as follows:

\$50.00 Purse – 1st – 30.00; 2nd - \$20.00. **Checks will not be mailed!**

STABLING - VERY IMPORTANT - PLEASE READ AND NOTE:

PERMANENT BARN (A,B,C,D): Contains 210 stalls and are located in the 4-H barns (B and C), Draft Horse barn (D) and Rabbit and Poultry barn (A). All stalls are permanent and equipped with either full doors or split top and bottom doors. The stall dimensions are either 10x12 or 10x10. Permanent barn stalls are \$65.00 per stall and tack/ready rooms are \$65.00 each.

GENERAL RULES: Stalls will be assigned first come, first served. The Show Committee, in its discretion, will assign barn fronts as necessary for the overall best interests of the show and will be charged an additional fee. The Show Management will resolve any conflicts with stall assignments. No exceptions will be permitted. **Exhibitors wishing to be stabled together must send entries in the same envelope! No exceptions!!!** Entries will not be stabled with a trainer unless that trainer has signed the entry form as the trainer for that entry. Each horse must be assigned a separate stall (except broodmares with suckling foals) and **MUST BE ENTERED IN THE SHOW.** Horses must be placed in the stalls assigned and no changes will be permitted except by the express consent of the Show Manager, Show Secretary and Barn Manager. Stabling will be available on Friday, August 7, 2009 through Sunday, August 9, 2009. If stabling is required before or after these dates, please contact the Fairgrounds. The Fairgrounds will collect a fee for arrivals prior to August 7, 2009 or departures after August 9, 2009. In order to assist the Show Committee with stabling assignments, it would be of assistance if stabling preferences are noted on the stabling request form.

FACILITY/GROUNDS FEE: A facility usage fee for exhibitors not purchasing a stall is \$25.00 per horse per day.

ARABIAN AND HALF/ANGLO-ARABIAN SHOWING RULES

Every class offered herein which is covered by the rules and specifications of the current USEF Rule Book will be conducted and judged in accordance therewith. We urge exhibitors to become members of USEF and AHA to familiarize themselves with the rules.

Limit horse classes are open to horses that have not won six first place ribbons at a regular member show of the USEF or CEF in the particular performance section in which shown.

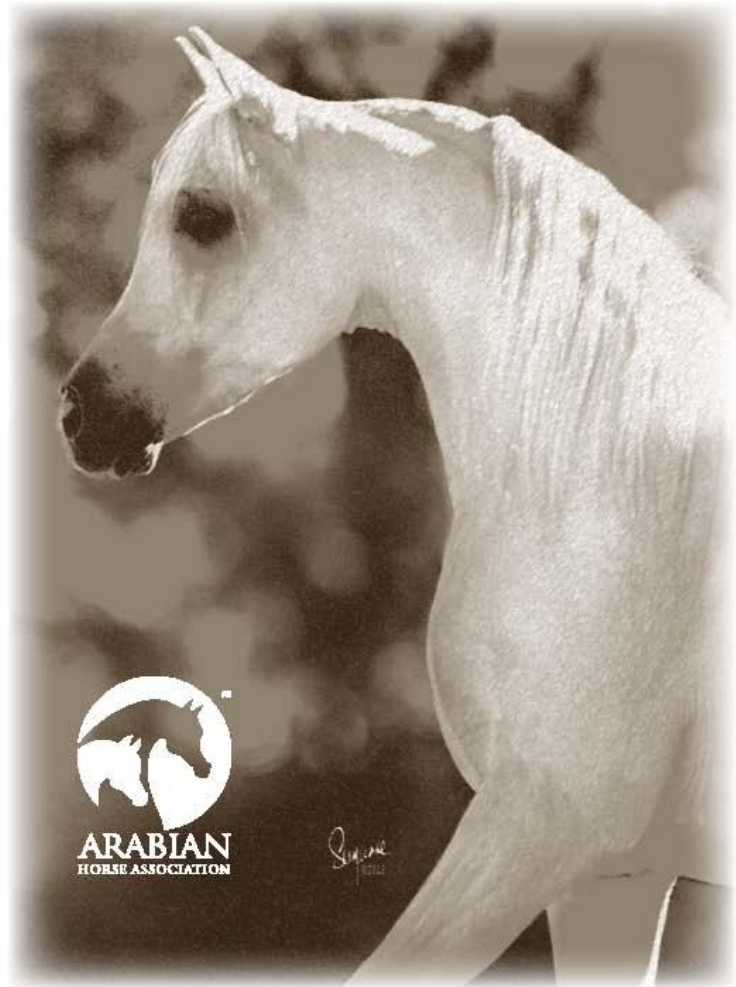

BREEDERS SWEEPSTAKES INFORMATION

Sweepstakes Points Payback Prize Money is available at every AHA recognized event.* Do you have a horse enrolled as an Original Entry, Breeding Entry, Gelding Entry or Yearling Entry? Then your horse is eligible to receive Sweepstakes prize money in Sweepstakes designated classes through the Points Payback Program. Simply enroll your horse before the first date of competition for \$100 to start accumulating points to be paid back at the end of the competition year.

How points will be paid out.

AHA recognized Shows and Events will receive 55% of the total collected funds will be paid. Total points earned each year in designated Sweepstakes Classes and rides will be divided into the 55% to determine dollar value per point. AHA will issue a check to the recorded owner of the horse (as of December 31 of the competition year) based on show and ride results for that year.

Sweepstakes Point Program

This is an optional program when all Sweepstakes requirements are met. Sweepstakes Nominated Horses must be enrolled in the Points Program in order to be eligible for prize money payout. Enrollments must be made on-line or postmark/electronic transaction dated to the AHA office before the first day of the event. Event management *may not* accept Sweepstakes Point Program Enrollments.
